#### **RESOLUTION NO. 892-2020**

DECLARING MUNICIPAL ORDINANCE NO. 2020-04 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "REQUIRING THE MANDATORY USE OR WEARING OF FACE MASKS BY ALL PERSONS WHO ARE WITHIN THE JURISDICTION OF THE MUNICIPALITY OF BUGALLON, PANGASINAN AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF" AS WITHIN THE CONFERRED POWER OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Municipal Ordinance No. 2020-04 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (5) (xii) of RA 7160; DILG Memorandum Circular No. 2020-071; Provincial Ordinance No. 240-2020 and the Omnibus Guidelines on the Implementation of Community Quarantine;

**WHEREAS**, however, the Sanggunian shall consider the points raised by the Provincial Legal Officer in her written opinion dated September 15, 2020;

**WHEREAS**, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;
