PROVINCIAL RESOLUTION NO. 894-2021

STRONGLY URGING ALL THE BARANGAY CAPTAINS TO DISCOURAGE MASS GATHERINGS TO ENSURE THE STRICT OBSERVANCE OF HEALTH AND SAFETY PROTOCOLS ISSUED BY THE INTER-AGENCY TASK FORCE

WHEREAS, the people of Pangasinan must continue to be alert and vigilant to the threat of COVID-19 in the Province although local transmissions have already slowed down in some areas of the country;

WHEREAS, barangay officials should be mindful of their duties and responsibilities to discourage the public to avoid attending, participating in, and organizing events that draw a huge number of attendees due to the still ongoing threat of the virus in the Province of Pangasinan;

WHEREAS, in order to minimize the risk of contracting COVID-19, the public must be advised to avoid crowded places and continue to practice self-protection measures by strictly observing minimum health and safety protocols;

WHEREAS, in order to keep Pangasinenses safe from the threats of the infectious disease, the Sangguniang Panlalawigan urges all barangay captains to discourage the holding of big gatherings and likewise the cancellation of planned events;

WHEREAS, the Sangguniang Panlalawigan is calling on all local government units more particularly barangay officials to be united in helping the national and provincial governments to further combat COVID-19 by suspending activities that could draw big crowd in their respective localities;

WHEREAS, this is one of the legislative measures being undertaken by the Sangguniang Panlalawigan to prevent the further spread of the disease in the community;



WHEREFORE, on motion of SP Member Jeanne Jinky C. Zaplan, duly seconded, it was –


