APPROVING SB RESOLUTION NO. 104-2020 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN. 2^{ND} **SUPPLEMENTAL** ENTITLED **"APPROVING** THE **INVESTMENT PROGRAM FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF MANAOAG, PANGASINAN"**

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its SB Resolution No. 104-Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Manaoag, Pangasinan prepared the municipality's 2nd Supplemental Investment Program for CY 2020. This was endorsed by the Council thru MDC Resolution No. 02, S-2020 dated July 21, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 104-2020 dated August 4, 2020;

WHEREAS, said Supplemental Investment Program, which has a total investment requirement of P6,465,575.75, covers augmentation funds for Personal Services (for the 5th Tranche Salary Increase, Hazard Pay and Special Risk Allowance of LGU personnel, MOOE, LDRRM activities, and implementation of other development projects of the LGU);
