## **RESOLUTION NO. 902-2021**

DECLARING MUNICIPAL ORDINANCE NO. 05-2021 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING THE SIXTY-NINE THOUSAND SIX HUNDRED THIRTY-TWO (69,632) SQUARE METERS MORE OR LESS OF PARCEL OF LAND COVERED BY TCT NO. 027-2014000470, LOCATED AT BARANGAY POBLACION, ANDA, PANGASINAN AND REGISTERED UNDER SPOUSES GILBERT C. SOSA AND NORAYDA O. SOSA, FROM AGRICULTURAL LAND TO COMMERCIAL LAND" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Anda, Pangasinan submitted its Ordinance No. 05-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator, Provincial Agrarian Reform Program Officer II, and Department of Human Settlements and Urban Development Regional Director have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 447 (a) (2) (viii) of R.A. No. 7160;

**WHEREAS**, the Municipality of Anda has an existing Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2013-2012, wherein said parcel of land is classified as agricultural under the agricultural zone;

**WHEREAS**, clearance for Reclassification (Certifications) from the Department of Agrarian Reform and the Department of Agriculture shall be secured and submitted to the Sangguniang Panlalawigan before the subject ordinance will be effected;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—

**RESOLVED,** by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 05-2021 of the Sangguniang Bayan of Anda, Pangasinan, entitled "An Ordinance Reclassifying the Sixty-Nine Thousand Six Hundred Thirty-Two (69,632) square meters more or less of parcel of land covered by TCT No. 027-2014000470, located at Barangay Poblacion, Anda, Pangasinan and registered under Spouses Gilbert C. Sosa and Norayda O. Sosa, from agricultural land to commercial land" as within the conferred powers of the Sangguniang Bayan to enact;
