DECLARING MUNICIPAL ORDINANCE NO. 2020-05 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "AN ORDINANCE IMPOSING RAPID TEST FEE FOR COVID-19 IN THE MUNICIPALITY OF BINALONAN, PANGASINAN AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWER OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2020-05 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 129, 132, 153 and 447 (a) (2) (ii) of RA 7160;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;
