S-2020 OF THE APPROVING RESOLUTION 250, PANGASINAN, OF BAUTISTA, SANGGUNIANG BAYAN ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM UNDER MDC RESOLUTION NO. 8, S-2020 OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN FUNDED UNDER SUPPLEMENTAL BUDGET NO. 4 CY 2020 LOAN PROCEEDS FROM LAND BANK OF THE PHILIPPINES AMOUNTING TO THIRTY MILLION PESOS (P30,000,000.00) FOR THE CONSTRUCTION AND RENOVATION OF PUBLIC MARKET OF BAUTISTA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 250, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Burgos, Pangasinan has formulated the municipality's Supplemental Investment Program No. 6 to be funded from LBP Loan Proceeds and endorsed thru MDC Resolution No. 08, S-2020 dated August 13, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan through Resolution No. 250, S-2020 dated September 1, 2020. This is in pursuance to Sections 106, 109, and 114 of RA 7160;
