RESOLUTION NO. 917-2020

DECLARING ORDINANCE NO. 21, S-2019-22 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING THE PARCELS OF LAND THAT COMPOSE THE PROPOSED SUBDIVISION DEVELOPMENT PROJECT OF COMMUNITIES PANGASINAN, INC. IN BRGY. ANONAS, URDANETA CITY, WITH A GROSS AREA OF TWENTY-FOUR THOUSAND FIVE HUNDRED SIXTY-ONE (24,561) SQUARE METERS, FROM AGRICULTURAL TO RESIDENTIAL USE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Ordinance No. 21, Series of 2019-22 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 20 (a) (2) (3) (c) (d) and Section 458 (a) (2) (viii) of RA 7160;

WHEREAS, however, the Sanggunian shall consider the points raised by the Provincial Legal Officer in her written opinion dated October 1, 2020;


