DECLARING MUNICIPAL ORDINANCE NO. 16, S-2021 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "AN ORDINANCE PROMOTING AND DEVELOPING ORGANIC AGRICULTURE IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Municipal Ordinance No. 16, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 16 of R.A. No. 7160, Republic Act No. 10068, otherwise known as the "Organic Agriculture Act of 2010" and Republic Act No. 9729, known as the "Climate Change Act of 2009";

**WHEREAS**, subject ordinance shall take effect after the requirements of public hearing, posting and publication pursuant to Section 59 (c) of RA 7160 is complied with;
