**PROVINCIAL RESOLUTION NO. 920-2020**

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS REGARDING THE TURNOVER OF TWO (2) COMPLETED ISOLATION FACILITIES LOCATED IN OPAG-STA. BARBARA STATION AND IN THE PANGASINAN REFORMATION CENTER - BURGOS**

**WHEREAS**, the Department of Public Works and Highways shall turnover to the Province of Pangasinan two (2) isolation facilities located in OPAg-Sta. Barbara Station and in the Pangasinan Reformation Center – Burgos;

**WHEREAS**, the completion of the isolation facilities is timely as there is a need to put patients in the area to avoid home quarantine;

**WHEREAS**, the isolation facilities would be of great help to the Province in reducing the cases of COVID-19;

**WHEREAS**, the isolation facilities will add on to the health care capacity of the Province of Pangasinan especially during this time that there is an increasing number of COVID-19 cases in Pangasinan;

**WHEREAS**, the duties and responsibilities of the Department of Public Works and Highways and the Province of Pangasinan are stipulated in the Memorandum of Agreement (MOA) which is made an integral part of this resolution;

**WHEREAS**, for the above purpose, a Memorandum of Agreement shall be entered into and signed a Memorandum of Agreement between the Province of Pangasinan, represented by Honorable Governor Amado I. Espino III, and the Department of Public Works and Highways, represented by its Regional Director Ronnel M. Tan;




