DECLARING MUNICIPAL ORDINANCE NO. 2021-06 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "AN ORDINANCE CREATING VARIOUS PLANTILLA POSITIONS IN THE LGU-BALUNGAO, PANGASINAN AND FURTHER APPROPRIATING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Ordinance No. 2021-06 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447(a) (1) (viii) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Salvador S. Perez, Jr. and Noel C. Bince and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2021-06 of the Sangguniang Bayan of Balungao, Pangasinan, entitled, "An Ordinance creating various plantilla positions in the LGU-Balungao, Pangasinan and further appropriating funds thereof" as within the conferred powers of the Sangguniang Bayan to enact;
