PROVINCIAL RESOLUTION NO. 926-2020

INVITING POLICE COLONEL REDRICO A. MARANAN, PROVINCIAL DIRECTOR OF THE PANGASINAN POLICE PROVINCIAL OFFICE AND MR. EMILIO P. SAMSON, JR., PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICER, TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN ON ITS OCTOBER 12, 2020 REGULAR (WEB-BASED/ONLINE) SESSION TO UPDATE THE BODY ON THE STATUS OF REPORTED INCIDENCES OF RAPE CASES IN THE PROVINCE OF PANGASINAN AND THE PROGRAMS BEING UNDERTAKEN TO ADDRESS THE SAME

WHEREAS, Section 16 of the Local Government Code of 1991 provides that every local government unit shall exercise its power to promote the health and safety of its people;

WHEREAS, the Sangguniang Panlalawigan, through the Chairman of the Committee on Children, Women, Senior Citizens, Family Affairs and Social Welfare, has expressed grave concern over the rising cases of rape in the Province of Pangasinan;

WHEREAS, the Sangguniang Panlalawigan is also alarmed that some of the reported cases of rape are incestuous and statutory that happened inside the house with the suspects being the relatives of the victims;

WHEREAS, there is a need, therefore, to inquire about the problem, in aid of legislation, and find solutions to it;

WHEREAS, the presence of the invited guests would greatly help the Sanggunian in the enactment of legislative measures to address the incidences of all forms of sexual abuse in the Province;


