#### PROVINCIAL RESOLUTION NO. 927-2020

APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 6 OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2020

**WHEREAS,** presented for consideration is the Supplemental Investment Program No. 6 of the Province of Pangasinan as endorsed by the Provincial Development Council thru PDC Execom Resolution No. 08-20;

**WHEREAS,** Supplemental Investment Program No. 6 contains other priority programs, projects and activities that are not included in the approved 2020 Provincial Annual Investment Program of Pangasinan;

**WHEREAS**, the Supplemental Investment Program No. 6 shall cover the purchase of heavy equipment and motor vehicles, purchase of hospital equipment and various infrastructure projects of the Province;

WHEREAS, funding for the full implementation of this Supplemental Investment Program shall be sourced from Land Bank of the Philippines Loan Proceeds (P950,000,000.00) financial incentive of the Rice Achievers Award in 2019 (P4,000,000.00) and 2016 (P1,000,000.00) from the Department of Agriculture, continuing and current appropriations — Capital Outlay of some offices (P2,766,200.00) and 20% Development Fund/Non-Office 2020 (P63,230,000.00);

**WHEREAS**, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;

**WHEREAS,** after careful study of the said Program, this august Body finds it to be in order;
