**APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) OF

FOR CALENDAR YEAR 2022**

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is the Annual Investment Program (AIP) of the Province of Pangasinan for CY 2022 and Supplemental to the CY 2022 AIP as endorsed by the Provincial Development Council thru PDC Resolution No. 01, S-2021 and PDC Execom Resolution No. 18-21, respectively;

WHEREAS, the Annual Investment Program of the Province of Pangasinan embodies the priority programs, projects and activities that address the basic sectors of development to be implemented in CY 2022;

WHEREAS, a total amount of P6,063,096,898.00 is required to finance the full implementation of the various programs and projects in the said AIP and its Supplemental;

WHEREAS, the AIP of the Province for CY 2022 embodies the priority programs, projects and activities under the four basic services of development such as General Public Services, Social Services, Economic Services and Other Purposes, the Development Projects Funded by 20% Development Fund, Disaster Risk Reduction and Management Programs/Projects and Investment Priority Areas;

WHEREAS, the AIP of the Province for CY 2022 is aligned with the priorities of the national government embodied in the AMBISYON NATIN 2040, 10-Point Socio-Economic Agenda of the President, Sustainable Development Goals and to the economic and social plans and strategies of COVID-19 pandemic and covers the devolved functions and services of the National Government to Local Governments;

WHEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


