APPROVING RESOLUTION NO. 2019-115 OF THE SANGGUNANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PLAN (SIP) NO. 01, CY 2019 OF SUAL, PANGASINAN AMOUNTING TO ONE HUNDRED FOURTEEN MILLION PESOS (P114,000,000.00)”

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2019-115 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Sual, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2019. This was endorsed to the Sangguniang Bayan for approval on October 9, 2019 by the Municipal Development Council thru MDC Resolution No. 03, S-2019 and was favorably acted upon by the Sangguniang Bayan on December 2, 2019 thru SB Resolution No. 2019-115;

WHEREAS, the Supplemental Investment Program No. 1 of the municipality covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of various municipal offices, various development projects and disaster risk reduction programs/activities of the municipality;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P114,000,000.00. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 01, CY 2019, which was passed and approved by the Sangguniang Bayan on December 2, 2019 through Appropriation Ordinance No. 02;
