RESOLUTION NO. 941-2020

DECLARING ORDINANCE NO. 07-A, S-2020 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING ORDINANCE NO. 07, SERIES OF 2020, ENTITLED “AN ORDINANCE CREATING THE PLANTILLA POSITION OF MUNICIPAL BUDGET OFFICER I UNDER THE OFFICE OF THE MUNICIPAL BUDGET OFFICER IN THE MUNICIPALITY OF INFANTA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Ordinance No. 07-A, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the power of the Sangguniang Bayan to enact ordinances and approve resolutions carries with it the power to amend, revoke, modify or repeal the same;

WHEREAS, the passage of Ordinance No. 07-A, S-2020 by the Sangguniang Bayan justifies the change of the position title from Budget Officer I to Administrative Officer II (Budget Officer I) to conform with the provisions of Budget Circular No. 2004-3 entitled “Conversion of Positions Performing Staff/Non-Technical Positions”;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject ordinance in order;


