APPROVING RESOLUTION NO. 2020-114 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL AIP PURSUANT TO APPROPRIATION ORDINANCE NO. 2020-004 OF THE MUNICIPALITY OF TAYUG, PANGASINAN INVOLVING AN AMOUNT OF TWO MILLION FIVE HUNDRED FIFTY SEVEN THOUSAND SEVEN HUNDRED FIFTY PESOS (P2,557,750.00)"

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Resolution No. 2020-114 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Tayug, Pangasinan has adopted and endorsed the municipality's Supplemental Annual Investment Program No. 4 through MDC Resolution No. 2020-05 dated September 7, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on September 15, 2020 through Resolution No. 2020-114. This is in pursuance to Sections 106, 109, and 114 of RA 7160;

**WHEREAS**, the Supplemental Annual Investment Program No. 4 with an investment requirement amounting to P2,557,750.00 which covers payment of hazard pay and fund augmentation of MOOE and Capital Outlay of the Office of the Mayor and Sangguniang Bayan, respectively;
