DECLARING ORDINANCE NO. 164, S-2021 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING FOR MOTORIZED TRICYCLE FOR HIRE (MTH) GUIDELINES, REGULATING THE FRANCHISING AND OPERATION OF MOTORIZED TRICYCLE WITHIN THE MUNICIPALITY OF BASISTA AND PROVIDING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
