DECLARING ORDINANCE NO. 164, S-2021 OF THE SANGGUNANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING FOR MOTORIZED TRICYCLE FOR HIRE (MTH) GUIDELINES, REGULATING THE FRANCHISING AND OPERATION OF MOTORIZED TRICYCLE WITHIN THE MUNICIPALITY OF BASISTA AND PROVIDING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 164, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
