#### **RESOLUTION NO. 961-2020**

DECLARING ORDINANCE NO. 138, S-2020 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE NAMING THE PARK LOCATED INFRONT OF THE MUNICIPAL GYMNASIUM AS "ATTY. ARTEMIO G. FRIAS PARK" AND PROVIDING POLICIES FOR ITS OPERATIONS AND MANAGEMENT" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 138, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 13 of RA 7160;

**WHEREAS**, the Sanggunian shall submit proof on consultation with the Philippine Historical Institute pursuant to Section 13 (a) of RA 7160;

**WHEREAS**, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of posting pursuant to Section 59 (a) of RA 7160;
