PROVINCIAL RESOLUTION NO. 965-2021

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III TO ENTER INTO AND SIGN THE MEMORANDA OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH IN CONNECTION WITH THE DONATION OF MECHANICAL VENTILATOR AND PORTABLE X-RAY FOR THE PANGASINAN PROVINCIAL HOSPITAL

WHEREAS, the Department of Health (DOH), as the principal agency of the government which consistently contributes to the upgrading of medical and health care facilities, has manifested its desire to further augment its support to the Provincial Government of Pangasinan's health care program through the Heal Covid-19 Project;

WHEREAS, the Heal Covid-19 Project serves as the national government's vehicle by which the Province of Pangasinan shall receive assistance in the form of a donation of equipment;

WHEREAS, the Province of Pangasinan, through the Pangasinan Provincial Hospital, will be the recipient of Mechanical Ventilator amounting to P853,944.00 and Portable X-Ray amounting to P4,600,000.00 from the Department of Health;

WHEREAS, the equipment can be used primarily and effectively by the Province to help further improve the capacity of the Province to detect, contain and treat COVID-19 cases;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to enter into and sign the Memoranda of Agreement with the Department of Health to further augment the need for the implementation of health programs and services to the people of Pangasinan;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Amado I. Espino, III, and the Department of Health, represented by Dr. Mario C. Villaverde, Undersecretary of Health;

NOW, THEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Amado I. Espino III, to enter into and sign the Memoranda of Agreement (MOA) with the Department of Health in connection with the donation of mechanical ventilator and portable x-ray for the Pangasinan Provincial Hospital;

RESOLVED, FURTHER, that the Provincial Governor shall be further authorized to sign all other papers and documents appurtenant to the Memoranda of Agreement;

RESOLVED, FINALLY, that copies of this resolution be furnished to the Provincial Governor, Amado I. Espino III, Province of Pangasinan, and Dr. Mario C. Villaverde, Undersecretary, Department of Health, and other concerned authorities, for their information and guidance.
