AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE CONCENTRIX CVG PHILIPPINES, INC. FOR THE ESTABLISHMENT OF A PARTNERSHIP WITH THE PROVINCE OF PANGASINAN FOR THE PROVISION OF WORK AT HOME EMPLOYMENT OPPORTUNITIES FOR PANGASINENSES

WHEREAS, one of the main thrusts of the Province of Pangasinan is to generate employment opportunities to the people of Pangasinan, especially during this period that many have lost their jobs due to the effect of the COVID-19 pandemic;
