**RESOLUTION NO. 970-2020**

**DECLARING ORDINANCE NO. 2020-21 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE STRENGTHENING THE BARANGAY COUNCIL FOR THE PROTECTION OF CHILDREN OF ALL BARANGAYS IN THE CITY OF ALAMINOS, PANGASINAN BY PROVIDING INCENTIVES THROUGH THE INSTITUTIONALIZATION OF THE MOST CHILD-FRIENDLY BARANGAY AWARDS” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2020-21 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16, 17 (b) (4) (iv), 458 (a) (5) (xiv) of RA 7160; Republic Act No. 7277, otherwise known as the “Magna Carta for Disabled Persons”; Republic Act No. 9262, known as the “Anti-Violence Against Women and Their Children Act of 2004; and Presidential Decree No. 603 entitled “The Child and Youth Welfare Code”;

**WHEREAS**, subject ordinance shall take effect after the Sanggunian has complied with the requirement of posting pursuant to Section 59 (a) of RA 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia and Jerome Vic O. Espino., duly seconded, it was –




