**ENDORSING TO THE DEPARTMENT OF HEALTH THE
UPGRADING OF THE HOSPITAL SERVICE CAPABILITY
OF URDANETA DISTRICT HOSPITAL FROM LEVEL I TO
LEVEL II AND THE UPGRADING OF ITS LABORATORY
FACILITY FROM SECONDARY TO TERTIARY**

WHEREAS, the Urdaneta District Hospital is presently categorized as a Level I Hospital operating under a 110-authorized bed capacity;

WHEREAS, the Urdaneta District Hospital has undergone major improvement and rehabilitation for the past years, especially in terms of bed capacity, laboratory, and other vital services;

WHEREAS, the Urdaneta District Hospital currently operates a new dialysis center which can cater to a number of patients daily, including an isolation and treatment facility for COVID-19 patients;

WHEREAS, due to the pandemic, the Urdaneta District Hospital has recorded a significant increase in the number of patients who preferred to come to the hospital thereby exceeding its authorized bed occupancy,

WHEREAS, if upgraded as Level II Hospital, the Urdaneta District Hospital can provide a more sufficient and higher level of medical and health services to the different localities of the 5th District of Pangasinan;

WHEREAS, the upgrading of its laboratory facility will likewise facilitate the services of the Urdaneta District Hospital in providing mass-based health care programs to accommodate all people especially the less-fortunate sector of the society;


