APPROVING RESOLUTION NO. 20-059 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 5 FOR CALENDAR YEAR 2020 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No 20-059 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council-Executive Committee of San Carlos City has prepared the city's Supplemental Investment Program (SIP) No. 5 for CY 2020. This was endorsed by the Council, through CDC Resolution No. 07-20 (S-2020) dated September 1, 2020 to the Sangguniang Panlungsod for approval. The Sangguniang Panlungsod approved said endorsement through Sangguniang Panlungsod Resolution No. 20-059 dated September 7, 2020;

WHEREAS, the Supplemental Investment Program which has a total investment requirement of P166,725,049.52 covers the augmentation of funds for Personal Services, MOOE and Capital Outlay of the different offices, and implementation of other development projects of the municipality;
