**APPROVING SB RESOLUTION NO. 168-2019 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 04-2019 OF THE MUNICIPALITY OF MALASIQUI, PANGASINAN IN THE AMOUNT OF TEN MILLION TWELVE THOUSAND SEVEN HUNDRED FORTY-ONE (P10,012,741.00) PESOS”**

**WHEREAS**, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its SB Resolution No. 168-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Malasiqui, Pangasinan has prepared the municipality’s Supplemental Annual Investment Program No. 04 for CY 2019. This was endorsed by the Council thru MDC Resolution No. 04-2019 dated October 15, 2018 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 168-2019 dated October 30, 2019;

**WHEREAS**, the Supplemental Annual Investment Program No. 04 has an investment of P10,021,741.00, to be sourced from the Municipal Share from Tobacco Excise Tax. Said amount will fund the project “*Improvement/Maintenance of existing municipal/barangay roads, concrete pavement of Farm-to-Market road, Barangay Lareg-Lareg*”, which is covered under RA 8240;
