DECLARING MUNICIPAL ORDINANCE NO. 02-09282020 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE MUNICIPAL HOUSING BOARD OF POZORRUBIO, PANGASINAN, DEFINING ITS POWERS AND FUNCTIONS, AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Municipal Ordinance No. 02-09282020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to RA No. 7279 (Urban Development Housing Act of 1992); Presidential Memorandum Order No. 74 dated September 13, 2002; Executive Order No. 708 dated February 26, 2008 Amending Executive Order No. 152, S-2002; and DILG Memorandum Circular No. 2008-143; and Sections 16 and 17 of RA 7160;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;
