RESOLUTION NO. 983-2020

DECLARING MUNICIPAL ORDINANCE NO. 04, S-2020 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY WEARING OF FACE MASK AND OBSERVE PHYSICAL DISTANCING AT ALL TIMES AND WEARING FACE SHIELDS AT PUBLIC PLACES/TRANSPORTATION BY ALL PERSONS/INDIVIDUAL WHO ARE IN THE JURISDICTION OF STO. TOMAS, PANGASINAN FOR THE MANAGEMENT AND CONTROL OF THE CORONA VIRUS DISEASE (COVID-19)" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Municipal Ordinance No. 04, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (iii), (5) (xii) of RA 7160; DILG Memorandum Circular No. 2020-071 (Mandatory Wearing of Face Masks or Other Protective Equipment in Public Places); the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments; Memorandum Circular No. 2020-014 of the Department of Transportation;

WHEREAS, however, the Sanggunian shall consider the observations of the Provincial Legal Officer, stated in her opinion dated October 10, 2020;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 04, S-2020 of the Sangguniang Bayan of **Sto. Tomas**, Pangasinan, entitled "An Ordinance requiring the mandatory wearing of face mask and observe physical distancing at all times and wearing face shields at public places/transportation by all persons/individual who are in the jurisdiction of Sto. Tomas, Pangasinan for the management and control of the Corona Virus Disease (COVID-19)" as within the conferred powers of the Sangguniang Bayan to enact;
