APPROVING RESOLUTION NO. 546, S-2021 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 03, CY 2021 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Lingayen, Pangasinan submitted its SB Resolution No. 546, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

**WHEREAS,** the Local Development Council of Lingayen, Pangasinan had identified items in their Supplemental Investment Program No. 3 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on November 29, 2021 through MDC Resolution No. 04, Series of 2021;

**WHEREAS**, the Supplemental Investment Program No. 3 of the municipality covers fund augmentation for the Personal Services (granting of Collection Negotiation Agreement Incentive to all municipal officials and employees) and Maintenance and Other Operating Expenses of the Office of the Mayor;
