AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN DEEDS OF DONATION AND RECEIVE ONE BRAND NEW CARDIAC MONITOR AND ONE BRAND NEW GENERATOR SET FROM THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT I FOR THE WESTERN PANGASINAN DISTRICT HOSPITAL

WHEREAS, the Department of Health (DOH) is the principal agency of the government which consistently contributes to the upgrading of medical and health care facilities and has manifested its desire to further augment its support to the Provincial Government of Pangasinan's health care program through the Health Facilities Enhancement Program (HFEP);

WHEREAS, the HFEP serves as the national government's vehicle by which public health care facilities receive assistance for infrastructure improvement and equipment upgrade;

WHEREAS, the Province of Pangasinan, through the Western Pangasinan District Hospital, will be the recipient of one brand new Cardiac Monitor (Brand Name: UNICARE, Model: FS MULTI-PARAMETER PORTAL MONITOR) worth P129,791.87 and one brand new Generator Set (250 KVA (3 Phase) with ATS (Brand Name: YANG DONG), Model: KD6.25-WY) worth P3,580,000.00), from the Department of Health-Center for Health Development-I in the form of donations;

WHEREAS, the equipment can be used by the Province to cater and respond immediately to the health necessities of the people especially in times of calamities and emergencies;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to sign the Deed of Donation and accept the various equipment from the Department of Health-Center for Health Development-I to further augment the need for the implementation of health programs and services to the people of Pangasinan;

NOW, THEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


