#### **RESOLUTION NO. 995-2020**

APPROVING SB RESOLUTION NO. 48, S-2020 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF BANI, PANGASINAN FUNDED BY THE GENERAL FUND, 20% MUNICIPAL DEVELOPMENT FUND AND TRUST FUND"

**WHEREAS**, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 48, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, and 114 of RA 7160. The Local Development Council of Bani, Pangasinan endorsed to the Sangguniang Bayan for approval the Revised Annual Investment Program CY 2020 on June 18, 2020 through MDC Resolution No. 2020-07. This was favorably acted upon by the Sangguniang Bayan on September 11, 2020 thru Resolution No. 48, S-2020;

WHEREAS, the 2020 Annual Investment Program of the Municipality of Bani was revised to integrate the Revised Local Risk Reduction and Management Fund Investment Plan (LDRRMFIP) prepared and endorsed by the LDRRM Council thru MDRRMC Resolution No. 03-2020. The LDRRMFIP includes programs, projects and activities (PPAs) in response to the crisis due to COVID-19 pandemic, which were proposed to be funded from portion of the municipality's unexpended balances of their LDRRMF CYs 2015-2019 Trust Fund in the amount of P7,482,091.00. This is in accordance with Section 2.5.5 of LBC No. 124 dated March 26, 2020;
