## **RESOLUTION NO. 996-2021**

DECLARING MUNICIPAL ORDINANCE NO. 16, S-2021 OF THE BAYAN SANGGUNIANG OF **BINMALEY**, PANGASINAN, ENTITLED "AN ORDINANCE CLOSING THE BAYWALK ROAD TO ALL KINDS OF MOTORIZED VEHICLES FROM BARANGAY BUENLAG (IN FRONT OF NORSEMAN BEACH RESORT) TO **BARANGAY BAYBAY LOPEZ (IN FRONT OF 567 RESORT AND** EVENT'S PLACE) DURING SATURDAYS AND SUNDAYS FROM FOUR O'CLOCK IN THE MORNING TO EIGHT O'CLOCK IN THE MORNING (4 AM TO 8 AM) FOR THE EXCLUSIVE USE OF THE CYCLISTS AND JOGGERS, REGULATING ITS USE DURING **CLOSURE AND PROVIDING PENALTIES THEREOF" AS WITHIN** THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO **ENACT** 

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Ordinance No. 16, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 21 of the Local Government Code of 1991 and Article 43 of its Implementing Rules and Regulations and Section 447 (a) (1) (iii) of the same Code;

WHEREAS, HOWEVER, alternate route/s for the said enclosed road/street and sufficient notice of announcement must be disseminated in order not to prejudice the public at large; and sufficient signages must be placed at strategic places, roads or alleys in order to notify the riding public;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Section 59 (c) and 511 (a) of R. A. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 16, S-2021 of the Sangguniang Bayan of Binmaley, Pangasinan, entitled "An Ordinance closing the baywalk road to all kinds of motorized vehicles from Barangay Buenlag (in front of Norseman Beach Resort) to Barangay Baybay Lopez (in front of 567 Resort and Event's Place) during Saturdays and Sundays from four o'clock in the morning to eight o'clock in the morning (4 am to 8 am) for the exclusive use of the cyclists and joggers, regulating its use during closure and providing penalties thereof" as within the conferred powers of the Sangguniang Bayan to enact;
