RESOLUTION NO. 997-2020

DECLARING MUNICIPAL ORDINANCE NO. 2020-06 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING PUBLIC COMMUTERS AND DRIVERS, AND EMPLOYEES, CLIENTS AND CUSTOMERS OF BOTH GOVERNMENT AND PRIVATE OFFICES INCLUDING COMMERCIAL ESTABLISHMENTS TO WEAR FACE SHIELD (ALONG WITH FACE MASK) AND OBSERVE AT LEAST ONE METER PHYSICAL DISTANCING WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY BUGALLON, **PANGASINAN DURING** THE **PERIOD OF COMMUNITY** QUARANTINE OR UNTIL LIFTED, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Municipal Ordinance No. 2020-06 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (iii), (5) (xii) of RA 7160; DILG Memorandum Circular No. 2020-071; Department of Transportation Memorandum Circular No. 2020-014 and Section 1 (E) of Executive Order No. 0033-2020 (Implementing Guidelines on Modified General Community Quarantine in the Province of Pangasinan);

WHEREAS, however, the Sangguniang Bayan shall consider the observations of the Provincial Legal Officer in her opinion dated October 21, 2020;

WHEREAS, subject ordinance shall take effect after the Sanggunian has complied with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2020-06 of the Sangguniang Bayan of **Bugallon**, Pangasinan, entitled "An Ordinance requiring public commuters and drivers, and employees, clients and customers of both government and private offices including commercial establishments to wear face shield (along with face mask) and observe at least one meter physical distancing within the territorial jurisdiction of the Municipality of Bugallon, Pangasinan during the period of community quarantine or until lifted, and providing penalties for violations thereof" as within the conferred powers of the Sangguniang Bayan to enact;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Bugallon, Pangasinan, for its information and guidance.
